The rates shown apply to Residential, Commercial and Industrial Customers if bills are paid by due date. Such rates are subject to adjustment for the cost of purchased natural gas. The charge per decatherm of this adjustment for this bill is indicated by the gas supply charge shown on the reverse side of this bill.

Late fees of 1.5% per month will be charged on accounts which are unpaid for more than two days after the due date of the bill.

1 Decatherm (DTH) – 1000 Cubic Ft. x BTU factor
 Facility Charge – fixed monthly cost for providing gas
 Gas Charge – cost of purchased gas
 State Tax – 2.4 cents per therm or 5 percent of the subtotal, whichever is lower
 IL Additional Tax – .01 percent Public Utility Tax Charge
 Municipal Tax – charged by your local municipality or town/city

BTU – heating value of gas.
 Distribution Charge – charge per DTH to deliver gas to meter

You may pay your gas bill by mail or in person at the Consumers Gas Company office in Carmi or Albion using cash, check, money order, or credit card, or payment can be dropped off at First Bank in Carmi. When paying by mail or in person, be sure to include or have the bottom payment portion of your bill with your check or money order. Payment may also be made through an ACH sign up which automatically withdraws payment from your checking account monthly.
